### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapor or mist. Provide adequate ventilation. ### Methods and materials for containment and cleaning up

Small spill

### Precautions for safe handling

**Protective measures**

# Appropriate engineering controls
